

Plumblink S.A (Pty) Ltd “WIN A VEHICLE” COMPETITION - TERMS AND CONDITIONS

1. **Who is the organizer:** This competition is organized and run by Plumblink SA (Pty) Ltd
2. **Who Can Enter:** All active account holders who spend a minimum R50 000.00 (excluding VAT) from 1st July 2017 to the 31st December 2017. There will be only one entry per entity/person regardless of spend over R50 000.00 excluding VAT.(ie; any active account holder – standard credit account, VIP or PCC account that spends R50000.00 or more will gain a single entry to the competition).
